

PRESIDENT'S CORNER

Greetings,

The holidays are history, and I hope that everyone's were safe, happy, and enjoyable. A lot of us have to keep hitting the pitching, so to speak.

Since the East Bay Regional Park District acquired the property next to the Club, we were informed that we have been encroaching on their land and it must be corrected ASAP. As I reported earlier, we negotiated with the District and agreed to a lot line adjustment, rather than a lease agreement. The agreement required us giving square foot for square foot in exchange for the adjustment.

In order to accomplish the exchange, unfortunately it was necessary to remove all of the pine trees on our border, which Richie & Kathy Stephenson planted many years ago. Unbeknown to them, 90% of the trees were not planted on our property, but they had no way of knowing at the time. We will have to replant a vision barrier after the District installs a fence on their property. The matter of the Park District becoming our new neighbor also brought an additional matter to bear. A significant amount of debris and other items that have been left or stored around the area has to be removed very soon, as well as a few containers and duck blinds relocated slightly. Anyone with "junk" or any other items next to or around their storage space will have to clean it up, remove it, **not** relocate it. Affected members will be notified if they have not already been, with directions on what has to be done. We have until the end of this month to get things in order.

On another note, we failed to have a quorum at the last membership meeting, which is the fifth time in the last seven months. All members should have received a ballot in the mail regarding proposed By Law revisions, one of which would eliminate the monthly membership meetings and establish an annual meeting on future election days. The proposed revisions will help streamline the Club's operations and eliminate the gross inconvenience of having members coming to a meeting, not having a quorum, and therefore no official meeting taking place. If you haven't voted yet please do so, as your vote does count. The ballots must be received by January 30, 2013 and will be counted on that day.
