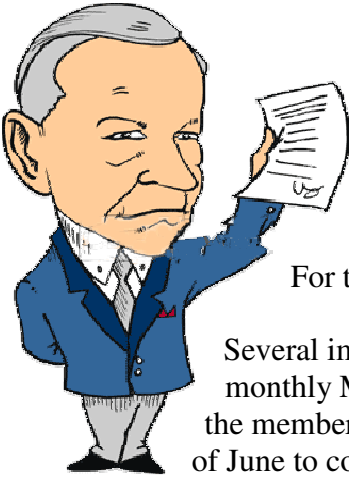

PRESIDENT'S CORNER



Greetings,

For those who do not know, the proposed By-Law revisions passed by a very wide margin.

Several important changes took effect when the By-Laws were approved. There will no longer be monthly Membership Meetings. The California Corporations Code requires that one meeting of the members must be held annually. We set the annual membership meeting for the last Wednesday of June to coincide with the annual election.

At the February BOD meeting, the Nominating Committee was established for this year's election. The committee consists of Walt Marshall, Robert Fahey, and Earl Brown. Nominations are NOW open for the following positions: five Directors, the President, Vice President, and Financial Secretary. Please contact anyone on the nominating committee in person or in writing/email with your nominations. Nominations will CLOSE at the April 4th BOD meeting.

Please note, there are no nominations from the floor any longer, so get your nominations in without unnecessary delay. Anyone wishing to submit a bio may do so, but it must be no longer than ¼ type written page, and must be submitted by noon, April 13th, in order to be published in the May & June bulletins. Bio's may be submitted via email to the editors of the bulletin, or type written and placed in the mail box marked Sportsman in the front of the Clubhouse. A word of caution: Bio's are to be autobiographic, civil, and the decision of the editors of the Bulletin is final (note from Editors: please only submit final copy pieces...no multiple revisions. Thank you!) .

Voting will be accomplished by mail-in ballots, same as the last By-Law revisions. Ballots will be mailed, so that you will have the month of June to vote, and mail your ballot or place it in the green drop box on the south side of the pump house. The balloting will close at the commencement of the June 26th Membership Meeting. Ballots will then be counted and the results will be made known. Those elected will take the oath, and assume their respective positions immediately. If you have any questions please contact me, any Board Member, or one of the Nominating Committee Members.
