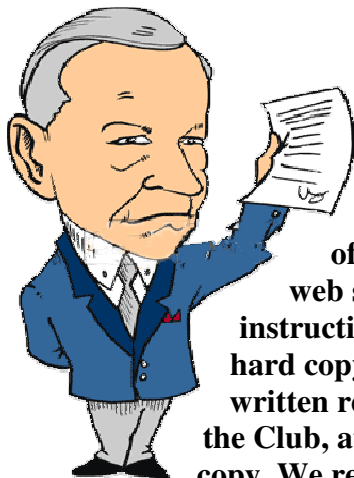


May 5th is the 1st Annual Bill Brazil Horse Races at GG Fields!

PRESIDENT'S CORNER



Greetings,

Starting back in September of last year, I mentioned monthly that you would be offered an opportunity to continue to receive the bulletin via USPS or view it on our web site. A self-addressed, stamped post card was included with the last bulletin with instructions to return it if you wanted to continue receiving a hard copy. This is the last hard copy you will receive unless you forwarded the postcard we provided, or you make a written request. If you misplaced the postcard, or changed your mind, mail a brief note to the Club, attention Vince Sargentini, indicating your desire to continue receiving the hard copy. We received approximately 600 cards back thus far, which is about 1/3 of our membership, resulting in savings of approximately \$10,000.00 per year. I want thank everyone for your participation.

I spent some time in the last bulletin describing the election process in an effort to avoid any repeat of last years' problems, which I won't go into here. I asked everyone to get their nominations in early and explained the process. I mentioned that nominations received by the nominating committee would be announced at the April membership meeting, and nominations would be taken from the floor and then nominations would close per our by-laws.

For those of you that don't know, I am 72 years old; I was a cop for over 30 years; I have over 20 years' experience in leadership roles in organizations such as ours and have been around the block a few times. I thought I had seen just about every type of bizarre behavior possible by adults. Well, live and keep being amazed! Long story longer, I made sure a member of the nominating committee was present at the April membership meeting to announce the nominees for the upcoming election and to record any nominations from the floor. I noticed a group of 8 or more members outside in the patio area when I drove up to the clubhouse, which is customary. 10 or 11 folks were in the hall and another group in the bar. At 7:02 pm, I called the meeting to order and, as all too often happens, we must empty the bar to establish a quorum. I waited for approximately 10 minutes, and Tom Frenkel went to the bar to advise folks of the meeting, but no one responded. Tom went outside and seasoned members were getting into their trucks and leaving. It was apparent that this was an orchestrated, organized boycott of the meeting for no comprehensible reason, other than obstruction of club business, and thereby wasting the time of those who attended.

This boycott had no effect on the nomination process. The nominations that were submitted are listed elsewhere in this bulletin and will be repeated in the June bulletin. There were no nominations from the floor, therefore nominations are closed, and the election will proceed according to the by-laws as scheduled.
